We hold field trips for all ages and provide specific educational lessons based on the needs of the student. We act as a living laboratory, and there are many "experiments" happening on the farm, including the use of composting toilets, living in tiny houses (with less "stuff" to clutter our lives), building with materials that are as sustainable as possible (reusing materials first if possible), utilizing rotational grazing methods for animals, growing chemical-free "clean" vegetables and herbs, creating our own soaps and medicinal tinctures, fermenting various types of food, and so much more. All of these topics we can teach to different strata of humanity. We believe that diversity is at the utmost of nature's success and will be ours as a non-profit and as a country.
